Tournament Rules & Policies

- A) Players must sign Release & Waiver of liability prior to play.
- B) Players must register at least 30 minutes before their match. Match time is the default time. Due to space limitations, the first 24 entries will be accepted in each event.
- C) Withdrawal - \$10 processing fee will be charged to any participant who withdraws in writing from the tournament prior to entry deadline.
- D) All participants must be a member of USATT & ITTF recognized body. Non members must pay membership fee with their entry form. Play will be conducted under ITTF rules. USATT dress codes will be enforced.
- E) Rating from the latest May 8, 2014 issued by USATT will be used. Non-rated players may enter any event, but will only advance in Open Singles and Non-rated events. Non Rated players do not need to have USATT Membership or rating in Non-rated events.
- F) Players may not enter in two events with identical start time. Events with insufficient number of entries may be canceled or combined at the discretion of tournament organizing committee. No prizes will be awarded for splits, dumps, default losses or no-shows. All referee decisions are final. ITTF racket testing rules will be enforced. ITTF or USATT approved equipment must be used
