Withdrawal: \$15 processing fee will be charged to any participant who withdraws in writing from the tournament prior to entry deadline.

Proof of Membership:

All participants must be current members of USATT or ITTF recognized body. Non members or those whose memberships have expired, must enclose membership fees with their entry form.

Rating: Rating from 9-2-2016 will be used for qualification.

(Non rated players may enter any event but will only advance in Open singles & age events.

Policies: Players may not enter two events with identical start time.

Events with insufficient number of entries may be cancelled or combined at the discretion of the tournament organizing committee. No Prizes will be awarded for splits, dumps, default losses or no-shows. Play will be conducted under ITTF rules. USATT dress code will be enforced. All referee decisions are final. ITTF racket testing rule will be enforced. ITTF OR USATT Approved equipment must be used.

Note: Over 40 RR maximum rating is 2000.
